This Contract was drawn up between _____, (owner of dam to be bred) and **Billy & Brandi long** (owner of stud dog) of Blue Line Bulldogs in mutual agreement of both parties.

Females must be minimum 15 months at time of stud service and less than 6 years of age.

The stud owner agrees to breed the above-named stud dog to the above-named bitch with the following conditions:

Stud Agreement:

___ #1 Option: Stud fee of **\$2,000.00** is to be paid before any breeding takes place.

Shipping and collection fee for every shipment must be paid before shipment is sent off.

All deposits on stud services are non-refundable.

Two live puppies at birth constitutes a litter. (If no visual/ghost Merle's are born a rebreed will be given at no cost to bitch owner except the shipping and collection fee for paid breeding only)

___ #2 Option: Second POL (2nd pick of litter)

Shipping and collection fee for every shipment must be paid before shipment is sent off

If only 1 puppy is born, stud owner will give the option to pay the stud fee and receive a rebreed in exchange for taking the POL.

Guarantees by The Stud Owner(s):

If the bitch fails to conceive, the stud owner(s) will offer a repeat stud service for the shipping and collection fee on the bitch's next season. This repeat service **ONLY** applies to the dog and bitch named above in this contract unless agreed upon by the stud owner(s).

Should the above-named stud dog die or become unfit to sire a litter after the first breeding attempt has failed, but before the conditions of this contract are met, the stud owner will offer a return service from another stud owned by the stud owner (if available) and mutually agreed upon between both parties. Not to exceed existing stud service fees; or a refund of the stud fee will be given.

Guarantees by The Owner of Bitch:

- The owner of the bitch will furnish pedigree and photos of the bitch to the stud owner prior to the breeding taking place.
- The owner of the bitch guarantees that the stud fee will be paid BEFORE the time of breeding and accompanied by a signed copy of this contract.
- Bitch owner must give at least a 24 hour notice prior to needing semen shipped in order to guarantee a shipment for the following day.
- All transportation charges and veterinary expenses incurred as part of, or as the result of this breeding shall be the responsibility of the owner of the bitch.
- Bitch owner agrees to confine bitch from any and all males during the entire duration of her heat Cycle.
- Bitch owner agrees if picking 2POL or POL that progesterone and a SI (surgical Insemination) will be done to impregnate said bitch, unless agreed upon prior.
- The owner of bitch agrees to notify stud owner in writing if the puppies display any genetic defect during their lifetimes that the bitch owner becomes aware of.
- The owner of bitch agrees that the bitch will NOT change ownership while she is in Whelp.
- The bitch owner agrees to furnish pictures of the litter once born and keep stud owner updated with pictures of the resulting litter. Bitch owner also agrees that stud owner may use any and all pictures of resulting puppies to show case stud productions

Puppy Back Conditions:

If second POL is selected stud owner has until 5 weeks of age to decide on their pick. Said puppy must be seen by a licensed veterinarian prior to leaving bitch owners Possession. If said puppy is unfit for sale or has ANY issues (not limited to cherry eyes, hernias, testicles not descending, heart murmur, etc) that would prevent the puppy to be available for sale until a further date, stud owner has the right to pick another puppy in its place per second POL agreement Said puppy must be current on all vaccines and deworming prior to leaving bitch owner possession. If said puppy is found to have parasites they must be treated before leaving. Stud owner WILL NOT sign off on AKC litter until second POL puppy is received by new owner or stud owner on or after 8 weeks of age. Once puppy is received and checked out within 48 hours by a licensed vet to be healthy and clear of any serious issues stud owner agrees to sign off on AKC papers. Bitch owner agrees to offer a one-year health guarantee on said puppy for any life threatening genetic health issues only. If said puppy develops a genetic life threatening issue within the first 12 months of life with proof bitch owner agrees to replace said puppy from one of their existing or future litters of a puppy with equal value. Shipping to return said puppy and to get replacement puppy is sole responsibility of whomever purchased said puppy. Once AKC applications are received by bitch owner, bitch owner agrees to send second POL AKC Application directly to Stud owner marked with FULL AKC no later than a month from signing off on AKC litter.
