PURCHASE AND PAYMENT

Buyer agrees to purchase the puppy identified above for the stated Purchase Price. The Deposit is non-refundable unless Seller agrees otherwise in writing or applicable law requires otherwise. The remaining balance is due before or at pickup (if the puppy is being shipped or transported, balance is due before that takes place) . Payment and acceptance of the puppy during pickup/delivery complete the purchase transaction, subject to this Agreement and the One-Year Health Guarantee.

HEALTH GUARANTEE

Buyer acknowledges receiving the One-Year Health Guarantee with this Agreement. The Health Guarantee is a separate document incorporated into this Agreement and controls all matters concerning the health warranty, including its requirements, covered and excluded conditions, claim procedures, remedies, and transfer provisions.

REFUNDS

Except as required by applicable law or expressly provided in the One-Year Health Guarantee, the Deposit is non-refundable and the Purchase Price is non-refundable after delivery of the puppy. A request for a refund does not create a right to a refund unless that right exists under the Health Guarantee or applicable law.

PAYMENT DISPUTES AND CHARGEBACKS

A chargeback, payment dispute, ACH return, or other payment reversal does not by itself establish that Buyer is entitled to a refund. To the extent permitted by applicable law and payment-network rules, Buyer agrees to provide Seller and the payment processor accurate information and supporting documentation concerning any dispute.

Buyer agrees not to knowingly submit a false, fraudulent, materially misleading, or knowingly unsupported claim for the purpose of obtaining money to which Buyer is not entitled. If Buyer does so, Seller reserves all remedies available under Texas law, including recovery of any wrongfully withheld or reversed amount and any legally recoverable attorney's fees, court costs, and other expenses.

ATTORNEY'S FEES AND LEGAL COSTS

If Buyer breaches this Agreement and Seller must take legal action to enforce it or defend against a claim caused by Buyer's breach, Seller may seek reasonable and necessary attorney's fees, court costs, and other recoverable legal expenses, to the extent permitted by law.

ENTIRE AGREEMENT

This Agreement and the One-Year Health Guarantee constitute the complete written agreement between Buyer and Seller concerning the puppy. If there is a conflict concerning a health-warranty matter, the specific terms of the One-Year Health Guarantee control. Any change or waiver of this Agreement must be in writing and signed by both Buyer and Seller, except where applicable law provides otherwise.

ONE-YEAR HEALTH GUARANTEE

This Guarantee is part of the Puppy Sales Agreement and applies only to the original Buyer and puppy.

Buyer must have the puppy examined by a licensed veterinarian within 72 hours after receipt. This is a condition of activating this Guarantee, if not provided this guarantee will be void. Buyer must provide the written exam record once received and immediately notify Seller of a potentially covered condition.

COVERED CONDITIONS

- Pulmonary stenosis.
- Genetic cancer-causing loss of life directly related to the genetic condition.
- Heart defect directly limiting life expectancy.
- Severe, life-threatening or life-altering kidney, pancreas, spine, or liver disease.
- Tracheal atresia.
- Seizure disorder.

NOT COVERED

- Everted laryngeal sacs.
- Elongated palate, nares/snares, or related surgery.
- Excessive skin folds.
- Skin allergies.
- Demodicosis.
- Parasites.
- Cherry eye or entropion.
- Loose hips / hip dysplasia.
- Failure to reproduce.
- Overheating / heat exhaustion.
- Hypoglycemia.
- Hypoplastic trachea.
- Color Dilution Alopecia.
- Minor, correctable, self-limiting, or breed-related conditions.
- Conditions caused by injury, neglect, improper care, environmental factors, or events after Buyer takes possession.
- Routine veterinary care, examinations, tests, medications, treatments, surgery, shipping, or other veterinary expenses.

4. CLAIMS & DOCUMENTATION

A claim must be made in writing with complete veterinary records and diagnostic testing establishing the diagnosis. Seller may request a second veterinary opinion before a remedy is provided and will forward to their vet for review. Buyer agrees to cooperate with a reasonable request.

5. REMEDY

If a covered condition is confirmed and all Guarantee requirements are met, Seller's remedy is a replacement puppy of comparable value when available. At no point is any refund of money from purchase sale, exam(s), test(s), care or treatment an option unless agreed upon by the Seller in writing. The puppy/dog then must be safely returned with its AKC registration papers and vaccination record before the replacement puppy is issued. Shipping and veterinary expenses are not included.

6. DEATH

For sudden or unexplained death during the Guarantee period, Buyer must obtain a necropsy/autopsy from a qualified licensed professional. If the cause is a covered condition and all requirements are met, Seller's remedy is a replacement puppy of comparable value when available.

7. TRANSFER

This Guarantee is void upon sale, gift, transfer, surrender, or other change of ownership unless Seller agrees otherwise in a written document signed by Seller.

8. LEGAL FEES / ENFORCEMENT

To the extent permitted by law, if Seller must enforce this Guarantee or defend against a claim arising from Buyer's breach, Seller may seek reasonable and necessary attorney's fees, court costs, and other recoverable expenses.

9. FINAL TERMS

This Guarantee is the complete health-guarantee statement for this puppy. Changes or waivers must be written and signed by both Buyer and Seller, except where applicable law provides otherwise. The remedies stated here are the contractual remedies for covered conditions.
